## Care Management

Care management is a mandatory service that includes on-going care assessment, planning and coordination. This ensures the services you receive meet the needs and goals identified in your Care Plan. Every Home Care Package will require some level of care management.

### St Anna's approach to Care Management encompasses;

- regularly assessing the person's needs, goals and preferences
- review their home care agreement and care plan
- ensuring their care and services align with other supports
- partnering with the person and their families or carers about their care
- ensuring their care and services are culturally safe
- identifying and addressing risks to their safety, health and well-being.

**Package management is a service that supports the delivery of a Home Care Package. This service includes activities such as:**

- *establish and manage home care budgets*
- *coordinate services (such as schedule services and workers or arrange respite care)*
- *prepare invoices and monthly statements*
- *respond to enquiries about invoices*
- *organise third party services*
- *buy equipment (such as mobility aids)*
- *arrange allowable home modifications (such as bath rails)*
- *submit claims to Services Australia*
- *maintain and update income tested care fee and basic daily fee payments*
- *paperwork for ceasing care*
- *store and maintain records*
- *ensure staff are suitable (such as with police checks and immunisation checks)*
- *train and educate staff*
- *conduct quality improvement, compliance, and assurance activities*
- *complete financial reporting*
- *maintain COVID-19 vaccination compliance documents.*

**Package management does not include:**

- *business overheads or costs*
- *administration and communication or marketing costs (include these in direct service prices as needed)*
- *care management tasks*
- *direct service charges.*

Standard hours are Monday to Friday 6:00am to 12:00pm. Non-standard rates commence from 12:00pm onwards. Minimum engagement for care support worker 30 minutes, excluding medication support which is 15 minutes. Billing increments are 15 minutes.

Minimum engagement for Enrolled Nurse 30 minutes. Billing increments 15 minutes.

Minimum engagement for Registered Nurse 60 minutes. Billing increments 15 minutes.

Minimum engagement for Garden & Home maintenance 60 minutes. Billing increments 15 minutes.

In-service kilometers charged at \$1 p/km. No exit or entry fees charged.

Late Cancellation policy - less than 24hrs and full fee will apply.
